

Los Nietos/Whittier Drug Trafficking Organization Defendants

Defendants in the main indictment (#1-31) all face a maximum sentence of life in federal prison, and all face mandatory minimum sentences of at least five years. Some defendants are also charged with substantive counts of narcotics possession and firearms offenses.
